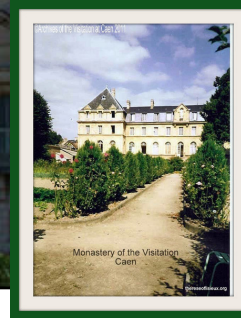

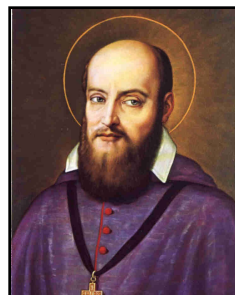

The Holy Trinity Apostolate Tentative Itinerary*

Day 1: Departure USA

Depart USA on overnight flight to Paris, France.

Day 2: USA / Paris, France / Caen

(D)

Arrive Paris and meet your European Tour Escort. Travel to Caen, the town where Sr. Francoise-Therese, Marie Leonie Martin, served the Lord in prayer as a Visitation nun. *Celebrate Mass in the Visitation Monastery where Leonie is buried, followed by a tour of the monastery. Benediction & Holy Hour.* Welcome Dinner and overnight in Caen.

Day 3: Caen / Omaha Beach/ Bayeux / Caen

(CB)

Breakfast, and then a visit to the *Memorial*, which is considered the best museum about WWII in France. This afternoon, journey to Omaha Beach and visit the *American Cemetery and Memorial*, pausing by the *Wall of the Missing* to remember all who fell on June 6, 1944. Return to Caen by way of Bayeux, the first town to be liberated during the battle of Normandy. *Celebrate Mass at the Cathedral of Notre Dame.* See the famous Bayeux Tapestry, which vividly recounts the story of the Norman conquest of England in 1066. Dinner on your own in Bayeux before return in the evening to Caen. *Benediction, Holy Hour and Reconciliation in Visitation Chapel.* Overnight Caen.

Day 4: Caen / Lisieux / Caen

(CB)

This morning, depart for Lisieux. *Celebrate Mass in the Lower Chapel Crypt in the Basilica of St. Therese.* After, tour of the Basilica, venerating at the crypts of Blessed Zelig & Louis Martin and the reliquary of St. Therese. See the video of the Life of St Therese in the Basilica Bookstore. Time for shopping in the bookstore after the movie. Next, a tour of Maison Buissonnets (St. Therese's House), finishing your time in Lisieux with some time for reflection in the Chappelle Du Carmel (St. Therese's Tomb). Return to Caen for independent dinner. *Benediction and Holy Hour in Visitation Chapel.* Overnight Caen.

Day 5: Caen / Alencon / Chartres / Paris

(CB, D)

Today, check out of hotel and travel to Paris, via *Alencon*, the birthplace of the Martin girls. Pass the St. Leonard Bridge where Zelig Guerin first bumped into Louis Martin. Visit Notre Dame Church, where Zelig married Louis Martin and where the Martin girls were baptized. Visit the house where the Martin children were born. Then, continue on with a stop to see Chartres Cathedral, not only a popular pilgrimage destination of the Middle Ages, but also one of the most amazing architecturally historic churches of medieval Europe. After, board motorcoach for remainder of journey to Paris for check in to hotel. Dinner followed by *Night Prayer in hotel.* Overnight Paris.

Day 6: Paris

(CB)

Today, a half-day Paris City tour with views of the Eiffel Tower, Arc De Triomphe, and a tour of the Church of St. Vincent de Paul. *Celebrate Mass at the church at Rue De Bac where St. Catherine Labouré received the vision of the Miraculous Medal.* Afternoon at leisure for independent visit to the Louvre (*pre-booking is advised for those who are interested*) or shop. Dinner on your own. *Night Prayer in hotel* and overnight Paris.

Day 7: Paris

(CB, D)

This morning, visit Ste. Chappelle founded by **King Louis IX** of France, who constructed it as a chapel for the royal palace and to house precious relics. See Cite' Island with Notre Dame Cathedral. In the afternoon, visit Montmartre, the House of Carmel, in the shadows of Sacre Coeur. After, *celebrate Mass at Sacre Coeur* with time for private reflection. Afternoon spent visiting the Rodin Museum. Dinner followed by *Night Prayer in hotel.* Overnight Paris.

Day 8: Paris / Nevers / Paray-le-Monial

(CB, D)

Depart Paris for Paray-le-Monial by way of Nevers. Arrive Nevers with half day guided city tour and visit to the convent of St. Gildard, the final resting place of St. Bernadette of Lourdes. Tour of convent grounds before *celebrating Mass at St. Gildard Convent.* Then, continue on to Paray-le-Monial, a picturesque town in the heart of the Burgundy region of France. Check in to hotel. Dinner, *Night Prayer in Prieure Chapel* and overnight Paray.

Day 9: Paray / Cluny / Ars

(CB, L)

Continental breakfast, then a tour of Paray-le-Monial, where the Sacred Heart of Jesus personally revealed himself to St. Margaret Mary Alacoque. *Celebrate Mass at the Chapel of Apparitions, which is served by Visitation nuns.* Visit the Basilica of the Sacred Heart and the Chapel of St. Colombière. Some time for reflection or to shop in the Basilica or Chapel of the Apparitions bookstores. After, visit a local winery to sample fine Burgundy wines paired with local cheeses, with a tour of Cluny enroute. Then, depart for Ars to visit the home of the simple curate of Ars, St. Jean Marie Vianney. See the house and shrine of St. John Vianney, the Patron Saint of Priests, and enjoy an audio presentation on his life. Check in to hotel. Dinner on your own. *Night Prayer in hotel.* Overnight Ars area.

Day 10: Ars / Annecy / Ars

(CB, D)

Early departure for Annecy, home to St. Francis de Sales and St. Jane de Chantal, co-founders of the Institute of the Visitation of the Blessed Virgin, for young girls and widows, known also as the Visitation Sisters. *Celebrate Mass in the Basilica of the Visitation.* Guided tour of Annecy. Visit to a local winery for a sampling of local Rhone valley wines. Farewell Dinner and overnight Ars area.

Day 11: Ars / Lyon Departure for USA

This morning, departure for Lyon airport. Bid adieu to France for your flight home.

PRICING TERMS: These are outlined adjacent to the estimated selling price listed in this brochure.

PAYMENT TERMS: In order to meet deposit schedules with suppliers for this tour, Corporate Travel Service asks for prompt payment on the requested dates. Please see the reservation form for the payment schedule. Corporate Travel Service also accepts Visa and MasterCard for payment. Traveler agrees not to dispute any credit card charges associated with this trip.

CANCELLATION POLICY: All cancellations must be received in writing. Forfeit \$100 per person for cancellation received from time of deposit to May 18, 2012. Forfeit \$350 for cancellations received between May 18, 2012 and July 7, 2012. Forfeit \$1,600 for cancellation received between July 7, 2012 and August 16, 2012. After August 16, 2012, no refund. **Penalties will be according to the fax or postmark date.**

CANCELLATION INSURANCE: Corporate Travel Service HIGHLY RECOMMENDS the purchase of travel insurance. In order to receive the optimum insurance coverage, purchase travel insurance within 14 days of deposit. Call Corporate Travel Service at 313-565-8888, ext. 151 or 152.

PASSPORT: A valid U.S. Passport is required of all passengers. Please apply for your passport immediately as passports may take a long time to process. Make sure to have it in your possession at all times while on tour. **It must be valid for 6 months following the return date of the trip or boarding may be denied or entry into the destination may be forbidden. Please provide Corporate Travel Service with a copy of the inside page of your passport (showing your name and photo) at the time of reservation.** A color copy is preferred. Fax copies are not acceptable.

GROUP AIR: Due to the airlines' reduced capacity and restrictive group reservation terms, group air reservations are often difficult to coordinate. The number of connections, length of layovers, and all conditions surrounding air travel cannot be guaranteed and may change before departure. Accordingly, if you require specific air travel needs and are not flexible concerning group air travel, **you may wish to consider purchasing a Land-Only package** and secure your own preferred air arrangements. In this case, you must notify Corporate Travel Service no less than 120 days before departure, be responsible for meeting the group at a specified location and time on the tour, and sign a Corporate Travel Service Land Only Waiver. TRAVEL DOCUMENTS: Unless otherwise notified, Corporate Travel Service will mail to you or your group leader a more detailed itinerary and General Information Sheet approximately 2 weeks or 10 days before departure.

ITINERARY: The Itinerary as presented in this brochure is tentative and represents what we are planning for you, however it is subject to confirmations from many organizations. Because of changes in local schedules, we may need to alter specified events, dates and/or venues to better fit the overall plan. The right is reserved to alter or cancel the itinerary, at Corporate Travel Service's sole discretion, as it may deem necessary or advisable.

GRATUITIES: Gratuities for your escort, driver and guides are not included. In Europe it is customary to tip the escort (3) Euros and the driver two (2) Euros per person per day. The tip for the local guides is usually about one (1) Euro for half-day tours and two (2) Euros for full day tours.

ROOMS: Tour prices are per person according to a room type: a "Single" room is one person in a room and a "Double" is two persons in one room. "Triple" rooms are discouraged because of cramped quarters. Triples are one double bed with two persons sharing the bed and one single bed. Triples are not always available.

LUGGAGE: Baggage is at owner's risk throughout the tour.

Checked Baggage: Fees are not included in this tour package price. Most airlines charge fees ranging from free to \$75 per bag one way. If traveling with group air, the air carrier for your flight will be announced in your final travel documents and an online link provided to learn the exact charges of your carrier. (Note: The website iflybags.com may be helpful and gives sample fees for all carriers.) Checked baggage is limited to **one** bag per person. There can be no exceptions. For most airlines, the one checked bag is limited to **50 pounds and 62 inches** (length + width + height). If these specifications are exceeded, excess charges may be collected by the airline at the airport. Do not lock baggage you intend to check in at the airport. Please confirm these specifications when you receive your final travel documents, as they can and do change.

Carry On Luggage: You may also bring a small carry-on bag that will fit under an airline seat and on the small parcel racks of the motor coach, which average about 8 inches high by 18 inches deep. It is best if your carry-on bag is soft sided, as the parcel racks on the motor coaches are small. Currently, travelers are allowed to transport only small amounts of liquids, gels, lotions, aerosols or similar items on their person or in their carry-on luggage. Details will be in your final travel documents.

HEALTH REQUIREMENTS: Travelers must be medically and physically fit for this tour. This tour requires significant walking, as motor coaches are not permitted to pick up and drop off in front of major attractions. The tour is not wheelchair accessible. Any special medical conditions or equipment must be advised in writing, for evaluation of feasibility, at the time of making your reservation. Should any special assistance be required, traveler agrees to bring a companion capable and willing to assist traveler.

CHILDREN UNDER 18: For a minor under the age of 18 to travel out of the United States without both parents or legal guardians, a notarized affidavit must be obtained and presented to immigration official upon departure and return to the United States. You may request a form from our office.

STATE DEPARTMENT & OTHER AGENCIES: From time to time the State Department (www.state.gov) and the Center for Disease Control (www.cdc.gov) and other government agencies and departments issue travel advisories or warnings for one or more of the destinations that you may be visiting on tour. We encourage you to contact these agencies directly to obtain the most current information. Corporate Travel Service cannot change the cancellation terms or conditions based on the issuance of any such warning or advisory or the occurrence of any terror, health or other incident in one or more of the places this tour is scheduled to visit. All cancellation penalties must remain in full force and effect as outlined on the reservation form.

PHOTOGRAPHY: Corporate Travel Service may take photographs or film of its trips and trip participants, and participant grants Corporate Travel Service express permission to do so and for Corporate Travel Service to use such for promotional or commercial use.

UNUSED SERVICES: There is no right to a refund for any unused services.
